

Questions for Senator Winnie Brinks

- 1. Could you help us better understand what led to the Baby Formula shortage due to the contamination?
 - a. Did the state have oversight over that factory?
 - b. What could have been done to prevent this emergency?
- 2. What have we done about the guaranteed consultation rights with the native Americans and the Canadians regarding Line 5. It appears that opportunity has not been afforded. What can we expect moving forward?
- 3. In this era of increasing threats of violence and partisan in fighting. Do you still see from your perspective peaceful paths through to introduce or infuse civility back into the legislative process?
 - a. How could Michigan lead the nation in this direction.
- 4. There is a petition drive to allow people to donate to a fund to pay tuition for private schools and their donations would be tax deductible. They are not presenting their signatures for the ballot because of polling numbers which showed 92% of people opposed. They are instead bringing it directly to the Legislation to try and push it through that way. What can be done to stop this charade?
- 5. What is being done to protect that safe and convenient means of voting for vulnerable seniors?
- 6. There is a current ballot proposal that would limit people to serve 12 years total which would likely lock people into the house and the senate. What are some of the benefits and some of the concerns about this.
- 7. Concerning the decrease of fossil fuel use and moving toward alternative energy sources, we would be curious to know what is being done to prepare for the increased use of our current infrastructure which appears to already be strained. Is there federal or state funding being directed in that direction?
 - a. Is this the responsibility of the utility companies in the private sector, the government, or both?

- 8. Please give us your perspective concerning open carry policies.
- 9. Where is the concentration of activity regarding Michigan's auto no-fault and the negative affect it has continued to have? Could you briefly update us if there is any impactful activity or new legislation to improve Michigan's auto no-fault and the affect it's having on home care providers and those needing but not receiving quality care or access to services?
- 10. What is being done at this time to improve the access adoption, and use of broadband and technology across Michigan?
- 11. What is in place to guarantee and protect the right of the seniors to vote in the most barrier- free way.
